Eligibility Criteria and Job Specification:

Educational Qualifications:

The candidate must possess a Postgraduate degree in Commerce/Economics/Management (with specialisation in Finance)/Statistics/Mathematics from a recognised institute/university in regular mode with a minimum of 60% marks.

Desirable Skills:

- 1) Minimum of 2 years of relevant professional experience for the position of Senior Research Assistant, preferably in research-oriented roles at reputed institutes.
- 2) Expertise in quantitative methods, familiarity with qualitative research approaches, and proficiency in R/Python.
- 3) Proficiency in MS Office Suite (Excel, Word, PowerPoint).
- 4) Good spoken and written English skills, attention to detail, teamwork, and learning orientation.

Job Specification:

The selected candidate will assist the faculty member in research activities, including data preparation, data analysis, and the drafting of academic reports and research papers, research proposals and grants.

This position is well suited for individuals planning to pursue a PhD and seeking rigorous research exposure and academic development.

Emoluments: The selected candidate will receive a consolidated monthly fellowship ranging from Rs. 40,000/- to Rs. 50,000/-, depending on qualifications and experience, plus HRA as per applicable norms.
