ADVERTISEMENT FOR ENGAGEMENT OF CONSULTANTS

Indian Institute of Management Lucknow (IIML), an autonomous Institution under the Ministry of Education, Govt. of India, invite **online** applications from the eligible Central Government/ PSUs/Autonomous Organizations employees, who have retired/ retiring in the next three months period i.e. upto 30.06.2026 for the following two contractual positions of Consultants at IIM Lucknow.

1.	Consultant (Library Services)- 01 post Upper Age Limit: 62 years.	ESSENTIAL QUALIFICATION: Graduate from a reputed Institute/University in regular mode with minimum of 60% marks. EXPERIENCE: Minimum 8 years of experience in the relevant area/task in Pay Level-10 & above.
2	Consultant (Secretarial Services)- 01 post Upper Age Limit: 62 years.	ESSENTIAL QUALIFICATION: Graduate from a reputed Institute/University in regular mode with minimum of 60% marks. EXPERIENCE: Minimum 8 years of experience in the relevant area/task in Pay Level-10 & above.

REMUNERATION:

A fixed monthly emolument shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement.

GENERAL CONDITIONS:

1. A candidate applying for the above position must be a citizen of India.
2. The term of appointment shall ordinarily be for an initial period not exceeding one year, which is extendable by another one year. Beyond two years after the age of superannuation where adequate justification exists, the term may be extended based on a review of the task and the performance of the contract appointee.
3. Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the selected candidate(s) at the time of retirement.
4. Mere fulfilling the eligibility criteria does not guarantee that the applicant will be shortlisted for the Selection Process. The Institute reserves the right to restrict the number of shortlisted candidates for further recruitment process to a reasonable number

on the basis of higher qualifications and/or relevant experience.

5. Once the application is finally submitted through the Google Form, no request for modification or correction shall be entertained.
6. The date for Selection Process will be communicated later to the shortlisted candidates **through email only**. The candidates are advised to check their emails regularly. Hence, Candidates are required to mandatorily mention their **email ID** in the application form.
7. Crucial date for determining the age limit shall be the closing date for the receipt of applications.
8. The Institute shall not be responsible for any delay or non-receipt of communication due to incorrect or inactive email ID provided by the candidate.
9. No rounding off of percentage (%) is allowed. Candidates are required to fill their exact percentage of marks while filling online application form.
10. **Selection Process**- The Selection Process shall be through an Interview, which may be conducted online, offline, or in multiple phases, as deemed appropriate by the Institute.
11. The shortlisted candidates will be required to bring all original Certificates, Degrees and other documents pertaining to their educational qualification, professional qualification, work experience, age etc. for verification purpose at the time of final selection process along with one set of photocopies of these documents.
12. In case of any dispute/ ambiguity/ confusion that may occur in the process of selection, the decision of the Director, IIM Lucknow shall be final and binding.
13. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to modify, withdraw or cancel any communication made to the candidates (Applicants).
14. Candidates are advised to visit the website of IIM Lucknow (www.iiml.ac.in) regularly for any updates, amendments and corrigendum. It will be placed on the Institute website only.
15. The panel of selected waitlisted candidates will be valid for one year from the date of approval of Competent Authority and the Institute can make appointments in future also by operating the panel within the validity period.
16. The number of posts may be increased or decreased as per the decision of the Competent Authority. The Institute also reserves the right not to fill any of the post, if it so desires.
17. Incomplete applications or applications received after the last date shall be summarily rejected.
18. No interim correspondence will be entertained or replied to.
19. CANVASSING IN ANY FORM WILL BE A DISQUALIFICATION.
20. Legal disputes if any will be restricted within the jurisdiction of Lucknow only.
