### Scope of Work

#### 1. Introduction:

The Centre for Marketing in Emerging Economies (CMEE), Indian Institute of Management Lucknow Noida campus, is seeking bids/proposals for the work of re-design, hosting, maintenance, and regular updating of their existing website, <a href="www.iimlcmee.in">www.iimlcmee.in</a>. The Centre for Marketing in Emerging Economies (CMEE) is a Centre-of-Excellence, based at the Noida campus of IIM Lucknow. CMEE was established in 2012 as a Centre of Excellence at the strategically located Noida campus of IIM Lucknow. Keeping in mind its vision of becoming a global center of excellence in generating and imparting knowledge in the field of management, CMEE is a lively resource center for scholars, academicians, marketing research practitioners, government functionaries, and corporations from around the world who have an interest in emerging economy markets. Celebrating its 11th year, CMEE has been successfully achieving its objectives of continuous education, research and publication, and networking. The centre is driven with able guidance from an eminent panel of globally renowned academicians and senior industry magnates who constitute its Governing Body and Research Team. Over the years, the centre has conducted 26 workshops and 03 international conferences with over 1000 participants from industry and academia. The papers presented have been published in internationally acclaimed journals. The center has published 13 research handbooks and 03 conference proceedings.

- **2. Objectives:** The primary objectives of this project are as follows:
  - a. To modernize and re-design the existing website, transitioning it from the present view to a latest version with enhanced visual appeal viewability and easy navigation across desktop browser-based web-view and mobile-responsive view, compatible across various devices.
  - b. To provide hosting services for the website on a reliable and secure server.
  - c. To offer ongoing maintenance and regular and timely content update support for the website.
- **3.** Re-design Requirements: The selected vendor should conduct a comprehensive analysis of the current website's structure, content, and design.
  - a. Develop a modern, user-friendly website design that is mobile-responsive.
  - b. Migrate existing content to the new design, ensuring data integrity and avoiding any data loss.
  - c. Implement SEO best practices for improved search engine & website visibility.
  - d. Incorporate a content management system (CMS) for easy content updates.
  - e. Use the latest web technologies, including Drupal, WCMS, HTML5, CSS3, and JavaScript, and/or any latest/relevant tools, technique and platform.
  - f. Ensure cross-browser and cross-device compatibility.
  - g. Ensure compliance with web accessibility standards (WCAG).
  - h. Create a user-friendly navigation structure.
  - i. Include interactive elements, such as forms and multimedia content.
  - j. Ensure cross-browser compatibility.
  - k. Re-design the thumbnail/gallery/carousel view on the homepage
  - I. Implement robust security measures to protect against common web vulnerabilities.
  - m. Conduct thorough testing and quality assurance before launch.

- n. Provide training and documentation for website administrators.
- o. Include the integration of IIML Online Payment Gateway
- **4. Hosting Requirements:** The selected vendor must:
  - a. Provide reliable hosting services on a secure server.
  - b. Ensure zero and/or minimal downtime, and, be functional 24x7x365, and a fast website loading speed.
  - c. Implement security measures to protect against cyber threats.
  - d. Regularly back-up website data to prevent data loss.
  - e. To observe state-of-the-art safety `and security measures
- f. Integration and Renewal of SSL Certificate and Auditing, website should allow a secured socketlayer. The website shall be security audited according to OWASP Open Web application Security Project application security verification standard
- **5. Maintenance and Updating:** The selected vendor will be responsible for:
  - a. Regularly monitoring and maintaining the website to ensure it runs smoothly.
  - b. Applying security patches and updates to the CMS, plugins, and other components.
  - c. Offering technical support and troubleshooting services as needed.
  - d. Updating website content, including announcements, events, publications, and news
  - e. Providing analytics and performance reports on a periodic basis
  - f. Once an update request is made from CMEE Office, the task should be completed latest within 04 06 hours, and, maximum within 08 hours. The urgency of update will be communicated accordingly depending upon its nature, i.e., Critical, General, etc.

- **6. Malicious Code Certificate:** The selected vendor should upload following certificate in the bid: This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious Code that would activate procedures to:
  - a. Inhibit the desires and designed function of the equipment.
  - b. Cause physical damage to the user or equipment during the exploitation.
  - c. Tap information resident or transient in the equipment/network.

The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.

**6. Timelines:** The re-design work is expected to be completed preferably within 15-days, and a maximum up to 30-days after the contract is awarded. The hosting, updating, and maintenance work will be done on a regular basis. The frequency of minor website update & announcement requests will be maximum up to 10 times in a month, and, shall increase more, when closer to any event/activity.

- **7. Proposal Submission:** Interested vendors should submit their detailed proposals, including a breakdown of costs, project timelines, relevant experience, and references, to the institute on or before the end of the last date of submission. The bidder should follow the bid-proforma mentioned as per Annexure A1, A2 (Technical Bid) and Annexure-B (Financial Bid)
- **8. Evaluation Criteria:** Proposals will be evaluated based on various criteria, including experience, cost, technical capabilities, and references.
- **9. Award of Contract:** IIM Lucknow reserves the right to select the most suitable vendor based on the evaluation process

#### 10. AMC Handover/Takeover and Knowledge Transfer:

- **a.** Handover and Takeover of all Technical, Functional and Training Documents/ modules and coding. The selector bidder is supposed to take the proper takeover from the present/previous vendor/authority. In future, the selected bidder will also be responsible to duly handover the above mentioned, as and when required.
- b. Knowledge transfer.
- **c.** Website Site Map walk through.
- d. Critical customization and enhancement walk through.
- e. Overview of critical issues raised during the support period.
- f. IT Infrastructure overview of static and dynamic pages
- g. A Knowledge Transfer completion certificate will be submitted by the vendor mentioning:

### **Eligibility Criteria**

- 1. The company should have duly valid GSTN and PAN registrations
- 2. The last 03 financial years i.e. (2022-23, 2021-22, 2020-21) annual turnovers of the company.
- 3. The company should have successfully executed at least 03 website management projects, including re-designing, development, implementation, and maintenance projects with total worth of five (05) lakhs.

- 4. Companies with minimum three (03) years' experience in website development and management for educational institutions (preferably Institute of National Importance, i.e., IITs, AIIMS, NITs, IIMs, etc.), are also eligible to apply
- 5. Certification ISO 9000 & ISO 27001 (and/or relevant/latest) series for Web Design Platforms/Software/Suites/Packages, for development, maintenance, security etc.
- 6. Bidders should not be under a declaration of ineligibility for corrupt and fraudulent practices.

**Evaluation Process:** Only those bidders who cross the threshold level of obtaining at least 50% of the total marks in Technical Evaluation shall be considered for the further evaluation. Scoring Parameters will be based on relevance and nature of past experience, consulting assignments, approach proposed, experience in domain area, experience and skill of core team etc.

**Evaluation of Financial Bid:** Financial proposals of only those companies who are technically qualified shall be opened on the date & time specified in the presence of the Bidders, representatives who choose to attend. The Evaluation Committee will correct any computational errors. When correcting computational errors, in case of discrepancy between the partial amount and the total amount, or between word and figures the former will prevail. In addition to the above corrections, the items described in the Technical Proposal but not priced shall be assumed to be included in the prices of other activities or items. IIM Lucknow will use Cost Evaluation under Combined Quality Cum Cost Based System (CQCCBS ), the technical proposals will be allotted weightage of 70% while the financial proposals will be allotted weightages of 30%. Proposals with the lowest cost may be given a financial score of 100 and other proposals given financial scores that are inversely proportional to their prices. Total score, both technical and financial, shall be obtained by weighing the quality and cost scores and adding them up. The following formula will be used to evaluate the overall ranking of the qualified tenders.

$$Overall\ Score = \frac{Score\ of\ Technical\ Bid\ x\ 70}{Highest\ Score\ of\ Best\ Technical\ Bid} + \frac{Lowest\ Financial\ Bid\ x\ 30}{Price\ of\ Financial\ Bid}$$
